Please feel free to contact us if there is any way we can help to make this one of your most memorable experiences of 2017.

Your Inclusive Package Includes;

Guaranteed 10 hours a day (dock to dock) which affords you a minimum of 7 to 8 hours of wet line time.

Un-limited "Custom" fish processing, packaged in portions for two, vacuum sealing, freezing, labeling and boxing of your catch. See page 2 for details.

Included your required fishing licenses & salmon stamps.

Included all fishing gear and tackle. We even supply rain gear & boots. However for that custom fit, you may want to bring your own. Our deckhand will wash down the decks often. Non-scuff footwear is preferred.

Included a full lunch is provided aboard, to include something fresh, something salty & something sweet, snacks, soft drinks, water, & fresh water ice are also included for any personal beverages you may choose to bring along.

Included Westmark Sitka is our primary lodging. Lodging while in Sitka is at the Westmark Sitka & considered to be one of Sitka's finest in lodging & amenities. The restaurant & bar boast an outside deck with seating & both full service.

***All package lodging is based on double occupancy.**

Included ground transportation in Sitka is provided to you for airport arrivals & departures, and to and from the harbor on each fishing day.

Note I arrive to the airport 25 to 30 minutes prior to your flight arrival and park literally feet from the terminal door. **I must stay with the vehicle**, so please feel free come outside, say hello & return for any checked baggage

****We fish only 4 anglers to a boat plus a crew of 2, your captain & deckhand. If you come to us as a party of 4, you "own the boat" which means no additional fishermen will be booked on your boat during your charter.**

OPTIONS “Buying the Boat” is choosing to limit your party exclusively to your party & specifically for 3 or less anglers. This option is not cost prohibitive, please ask or email for details: Octobre’s cell is 907-738-3322 & email is reel.affair@att.net

OPTIONS With most “outfitters” and fishing packages, the dates run consecutively. Occasionally folks want to fish longer, but sometimes 4 or 5 consecutive days of fishing can be overwhelming, so talk to me & I will add a “Lay Day” anywhere you see fit, but we must schedule it well in advance.

Example

Change to: 4 Days Fishing **6** Nights Lodging (was a 4 days 5 night pkg.)
Arrive on Thursday,
Fish: Friday, Saturday,
Off Sunday, (Lay Day)
Fish: Monday & Tuesday,
Depart Wednesday

* To receive the discount Cash, Personal Checks, Money Orders & Cashier Checks are accepted for both the deposit & the balance, & must be in US Funds.

* If you choose not take advantage of the discount we offer & opt to use “Plastic”, we gladly accept Visa, MasterCard, Discover and American Express for either the deposit, the balance or both.

DEPOSIT & BALANCE

How it works upon scheduling dates;

- 1.) We email you all the info & details of your specific package.
- 2.) You are originally quoted the discounted rate on each person's invoice
- 3.) The deposit due is \$500.00 per angler within 10 days.
- 4.) Each group/person is given a deposit "due" date.
- 5.) If you choose to deposit in a form other than "plastic" I honor the discounted rate.

When either the deposit or the balance are paid in a form other than Cash, Personal Checks, a Money Orders or Cashier Checks, the loss of the discount (Adding 5.5%) will apply to the original invoice balance which includes taxes, the charter package, and any other additional "extras" you may have chosen to add to your charter package.

- 6.) Balance is due on your arrival day to Sitka, AK

Should any guest(s) in a "party" choose to use "plastic", this only affects the specific person's invoice & not those who chose the discounted rate.

* Package prices quoted here do not reflect Sitka Sales Tax is currently 6% and caps at \$3000.00 per folio, Sitka Bed Tax or Sitka Fish Box Tax.

Taxes Package prices do not reflect Sitka Sales Tax or Sitka Fish Box Tax:

***Sales Tax** is at 6%, & caps at \$3000.00 per person,

***Sitka Fish Box Tax** is \$10.00 per box & is not included in any of our packages, and we would have to "Guess" how many fish box(s) you are departing Sitka with. Sitka Fish Box Tax is collected on your departure.

UNLIMITED CUSTOM PROCESSING of your "catch" to your specifications is included in your All Inclusive Package. Your options include: Fillets, Steaks, Butterfly Fillets, in the "Round" and Whole Side Fillets for your back yard party. Each and every day you may change your mind, meaning if you choose steaks one day you may choose fillets the next. Variety is a great thing!

SMOKED FISH There is an additional cost for smoking your 'catch'. The cost to you is \$4.00 lb. on the incoming weight. You are receiving back the fish you tuned in to have smoked.

- 1.) **When fishing 2 days – you can turn in your fish for smoking on day 1 (if time allows for smoker)*
- 2.) **When fishing 3 days – you can turn in your fish for smoking on day 1*
- 3.) **When fishing 4 days – you can turn in your fish for smoking on day 1 & day 2*
- 4.) **When fishing 5 days – you can turn in your fish for smoking on day 1, 2 & 3*

SEAFOOD PACKAGING is done in portions for 2 unless otherwise requested, packed & vacuum sealed in a 4 mil pouch, each package is labeled for easy identification & frozen to minus 25 degrees (-25degrees)

WHAT IS NOT INCLUDED IN OUR PACKAGES?

*Cost of Airfare & the Alaska Marine Highway (State Ferry)

*Morning Meal

*Evening Meal

“Lay Days” (additional lodging added to a package)

*Transportation to & from the ferry terminal is based on our availability & not available from 5 pm to 9 am.
