

CARE OF YOUR SEAFOOD:

THE FISH HOUSE: We have operated our own fish processing facility since 2000, & have control of your catch. We do not use an “outside” vendor. It’s important that the fish you caught is exactly what is in your box(s). We won’t swap the previous days frozen for today’s fresh. Our self-imposed standards are impeccable. The fish house is spotless. Our feelings are simple “A facility should never smell like what you do there.” :-)

CUSTOM CUTTING of your catch daily. Choices are: steaks, fillets, butterflied, whole-side fillets, or smoked.

PACKAGING & FREEZING: Within hours of being caught by you, your seafood is packaged in portions for 2, and vacuum sealed in .4 mil pouches. Every package is labeled by specie, for easy identification, and frozen to -25 degrees.

COST: Processing is \$2.45 per pound, being charged only on the outgoing weight (the weight you take home).

BOXING: Processing costs do not include the boxes needed to properly box your catch for shipping or the added insulation needed to maintain it in a frozen state until you arrive home. Proper packaging by our facility, given your distance to travel, & summer temperatures in the lower 48 will allow you 30+ hours of travel time from my freezer to your freezer. The insulation is all reusable and inexpensive insurance. We do maintain a full inventory of boxes & insulation perfect for the job, so please keep your coolers at home.

STORAGE & SHIPPING: If needed we have the ability to hold your seafood, and ship to you via FEDERAL EXPRESS or ALASKA AIR CARGO upon your arrival home. We will hold your “catch” at no added charge for 2 weeks from your fishing date. Extended hold overs? A minimal storage fee will apply. We cannot hold fish for an extended period after 8/20. Shipping costs are not paid

by Alaskan Reel Affair Charters LLC & are the responsibility of the recipient or angler. Cost will depend on weight & location. *Remember if flying, your seafood is checked baggage and the most cost effective. We suggest you travel lightly with carry-on luggage only.

CANCELLATION POLICY:

- 1.) Cancellations received prior to January 1, 2017: Should folks need to cancel their charter for any reason the deposit is fully refundable.
- 2.) Cancellations received Jan 1, 2017 and later: The deposit is fully refundable when your confirmed reservation is booked & confirmed by another person/party. Otherwise, the deposit is nontransferable & nonrefundable.

OTHER CONSIDERATIONS

Travel or trip insurance is readily available from many vendors & can offer protection for unplanned interruptions while on vacation.

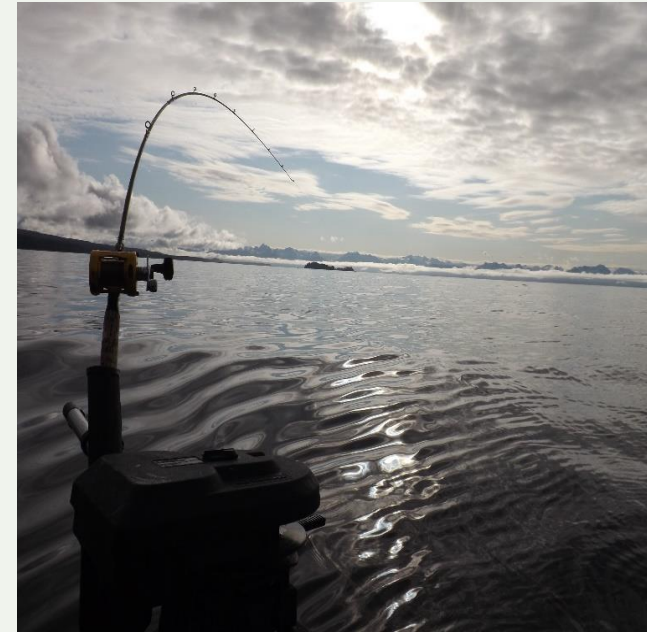

WE FISH ONLY 4 ANGLERS TO A BOAT plus you'll have a crew of 2: your captain & deckhand. When you are a party of 4, you "Own the Boat" which means no additional fishermen will be booked on your boat during your charter.

OPTIONS: "Buying the Boat" reserves the boat for your party exclusively, and specifically for 3 or less anglers. This option is not cost prohibitive, & very

popular. Please ask about the details & benefits. *October's cell is 907-738-3322.*

DEPOSIT: A deposit of 50% or \$500.00 per person (whichever is less of the invoice balance) is requested within 10 days of booking and receipt of our confirmation email. The balance is due on arrival in Sitka.

CHOOSING YOUR DATES:

What determines the beginning of our charter season in Sitka as well as its end is simply this: water and weather conditions. Whether you're targeting Salmon, Halibut, Yellow Eye, Rock Fish or Ling Cod.

THE FISH ARE HERE!



We are not "date sensitive" as lakes or rivers may be. Our charter fishing season is from mid-May through early September. You can choose the time of year that you prefer to fish by the salmon species (King or Coho) you want to target. Keep in mind your Halibut, Yellow Eye, Ling Cod & Rock Fish are available all season long. *ADFG regulations can be found on www.reelaffair.com

• May and June are predominantly King Salmon/Chinook.

• Early July is an excellent time for a mixed bag; it is the beginning of our Silver Salmon run, with a strong showing of Kings.

• Mid-July through August, and early September are predominantly Silver Salmon.

Halibut, Yellow Eye, Ling Cod & Rock Fish are available all season long.
